## About the Awards

India continues to be among the fastest growing economies globally, and manufacturing has the potential to emerge as one of the highest growth sectors in India. The Indian Government, in line with its "Make in India" objective, has set an ambitious target of increasing the contribution of manufacturing output to 25% of gross domestic product (GDP) by 2025 - which is a 9% increase from the present level of 16%. India has a massive workforce, an emerging supply base, and access to several natural resources needed in production. India could create 60 million to 90 million new manufacturing jobs and become an attractive investment destination. To capture the available opportunity, India's manufacturing sector will have to improve its efficiency dramatically. If these core advantages are capitalized well, India is well poised to become the world's fifth largest manufacturer by 2020.

The Awards for Excellence in Manufacturing are instituted by CII to catalyze significant and innovative practices in the manufacturing sector, thereby facilitating a future-looking, and a sustainable growth for the Indian Industry. With these Awards, CII aims to recognize efforts by manufacturing enterprises for implementing new and innovative manufacturing systems and outstanding achievements. It is also hoped that the Awards would trigger a Manufacturing Renaissance in India.

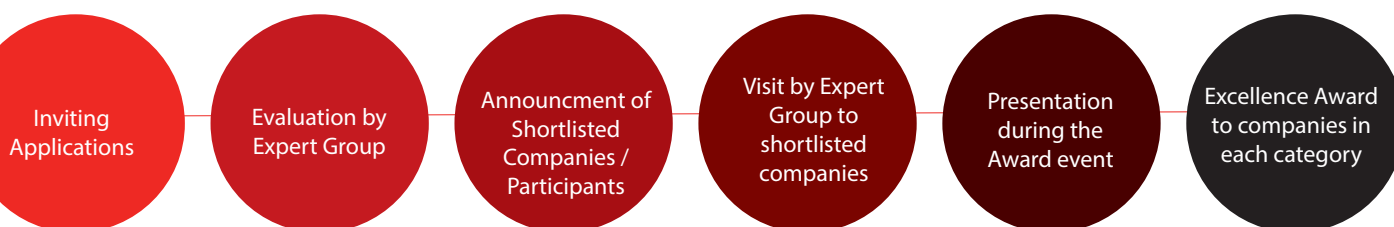
### Companies - A Company/SBU/Unit Level awards in two separate categories

- SME Industries (Revenue< Rs. 250 Crore)

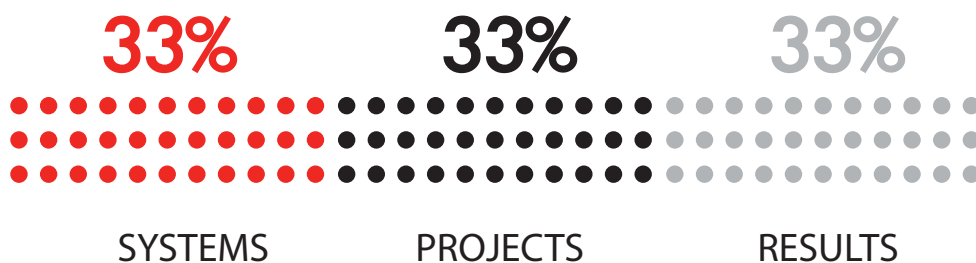
### Individual

Presentation by Shortlisted companies including Awards function

Two companies each from the Large Scale and the SME segments will be shortlisted for final presentations for each category of the Awards.

Shortlisted companies [20 in total] to make Presentations over 2 days -

- Template to be shared and companies to present as per template
- 20 Mins. of Presentation and 10 Mins. of Q&A only by judges
- Based on presentation, the judges to decide category of awards for companies

At the end of Day 2, the companies and the individuals would be awarded based on judges evaluation

**In addition, 4 Emerging Young Leaders to be shortlisted [2 from Large companies & 2 from SMEs] for presentation over two days.**

## The Awards

For each Category – One Excellence Award for LARGE Scale Enterprises and One Excellence Award for SMEs

For Individual Awards – One Excellence Award for Young Leaders from Large Scale companies and One Excellence Award for Young Leaders from SMEs

All shortlisted entries will receive a specially written and crafted citation plus an assessment report by the Expert Group listing their observations
