# CII PINNACLE AWARDS FOR EXCELLENCE IN MANUFACTURING 2022

CII Pinnacle Awards for Excellence in Manufacturing, instituted in the year 2019, is India's one of the most prestigious Awards for Excellence in Manufacturing that any Indian company can aspire for.

India continues to be among the fastest growing economies globally, and the Government, in line with its "Make in India" Initiative, has set the three ambitious objectives: to increase the manufacturing sector's growth rate to 12-14% per annum; to create 100 million additional manufacturing jobs in the economy by 2022; to ensure that the manufacturing sector's contribution to GDP is increased to 25% by 2025. The Award aspires to help in all these three stated objectives.

The Awards is based on a comprehensive Evaluation Framework, developed by CII Naoroji Godrej Centre of Manufacturing Excellence. The Framework covers seven different segments and offers a 360-degree approach towards measuring and recognizing an organisation's performance in their journey towards Manufacturing Excellence.

## ELIGIBILITY

The following may apply :

1. Companies/ Firms registered in India as a legal entity
2. For MNCs, the Indian Subsidiary to apply
3. Large organisations can apply at Plant/ SBU/Unit Level
4. Companies/ Firms from the MSME Category

### Large Enterprise

**Revenue** > INR 250 crores  
**Investment** : Above INR 20 crores

### MSME

**Revenue** < INR 250 crores  
**Investment** : Less than INR 20 crores

\*Enterprises engaged in the manufacture or production, processing or preservation of goods. Investment in plant and machinery is the original cost excluding land and building and the items specified by the Ministry of Small-Scale Industries vide its Notification No.S.O.1722(E) dated October 5, 2006.

#Proof of the investment figure (a certificate by the auditors) is to be shared at time of Registration. In case of a CII Member, company's membership certificate would suffice.

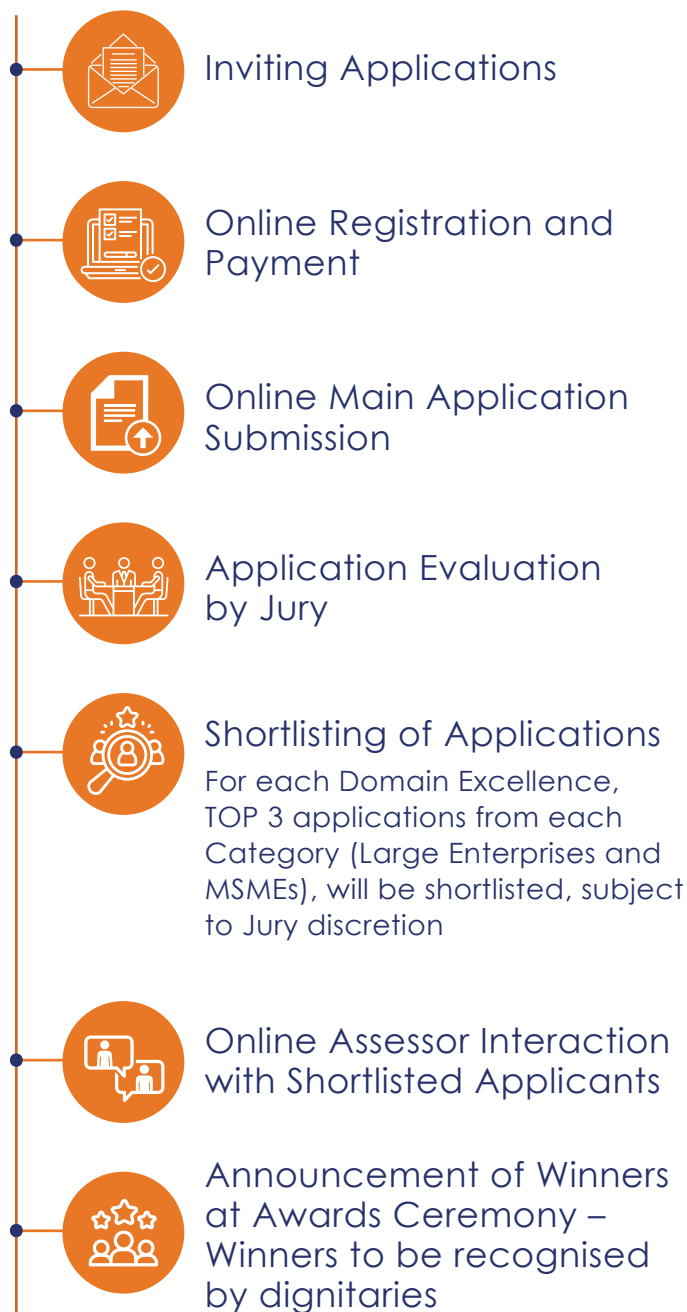
## ASSESSMENT CRITERIA

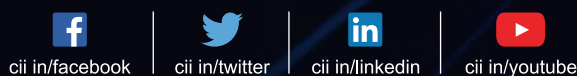
