- 1. [Please check with CII Awards Team for eligibility before Registration and Payment, if required].
- 2. This decision is at the sole discretion of the Awards Team and no requests will be entertained.
- 3. The Application Form requires the signature of the Official Representative of the Company for that particular application. The signature indicates that all the information contained in the Application is correct, that fee will be paid, and that all requirements of the submission and the eligibility rules will be met.
- 4. The Participation Fee, once paid, is non-refundable and non-adjustable (against any other CII programmes).
- 5. Any Government taxes and levies, will be charged, additionally at actuals, as is prevalent and applicable.
- 6. An applicant may not like to pursue with the Awards at any point of time. In such case, Participation Fee will not be refunded.
- 7. The Point of Contact filling up the Registration Form need to participate during the assessment process, as and when required.
